

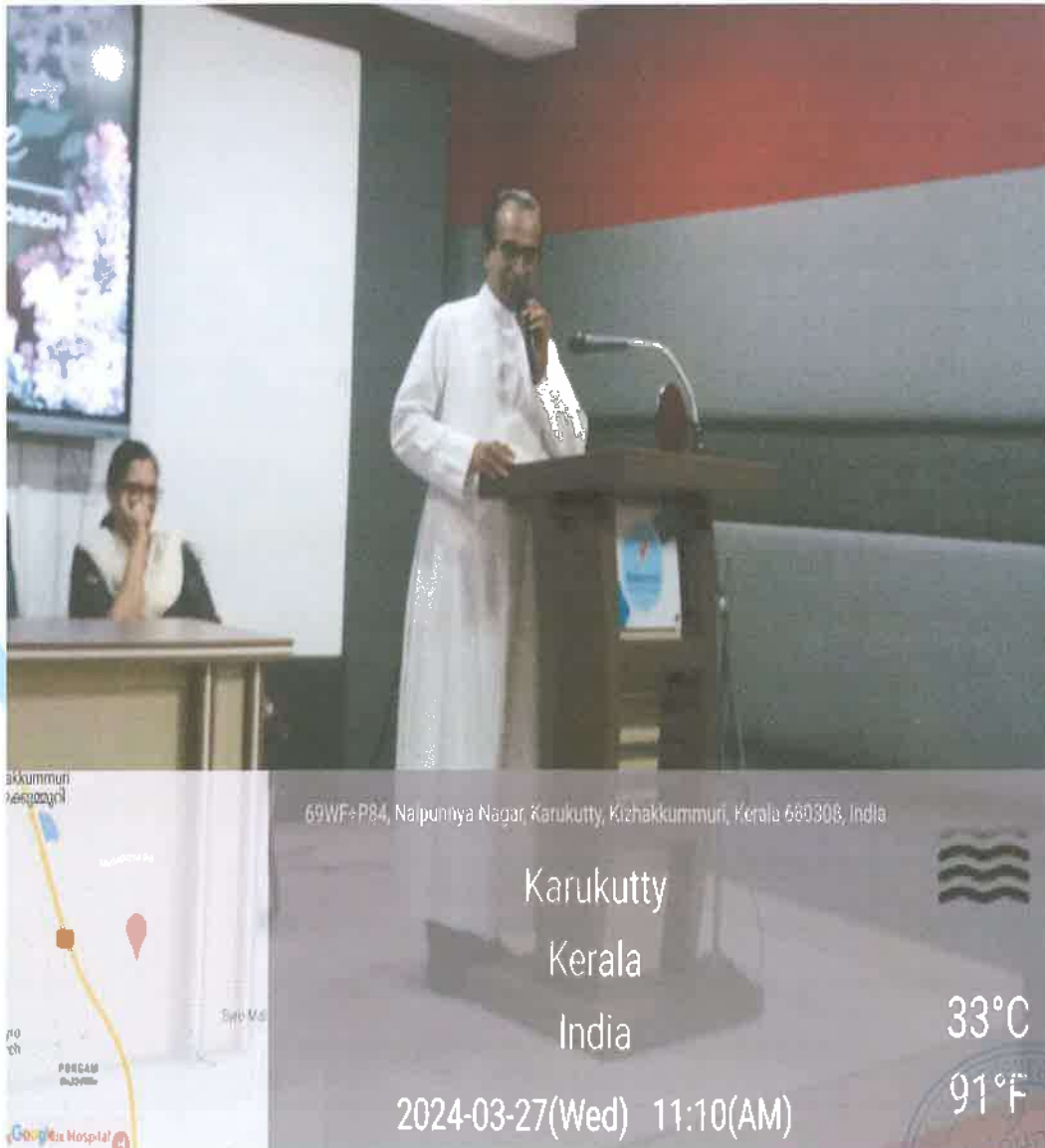


RESOURCE PERSON'S PROFILE
